About us

Here at the Hospice of St Francis, we provide essential and expert care either at home or in our In-Patient Unit, for adults with a life limiting illness, as well as supporting their loved ones at the most difficult of times.

Our free care costs over £5 million every year and with less than 20% of our funding coming from the NHS, we rely heavily on the kindness of our wonderful supporters, especially people who leave a gift in their Will.

Leaving a gift in your Will

A gift in your Will, regardless of size, means you are directly supporting those who need it the most, for generations to come.

If you consider leaving us a gift in your Will, there are three kinds of gifts you can leave:

“I put the Hospice in my Will because I wanted to do something useful. Perhaps, in the future, hospice nurses will benefit from what I’ve given.”

- 1** A cash gift is a fixed amount of money of your choice.
- 2** You can choose to leave specific items, such as your house, jewellery or household items such as art.
- 3** You can also choose to leave a residuary gift, which is a percentage or share of the balance of your estate once all other payments and gifts have been made. This is an easy way of helping The Hospice of St Francis without having to decide on a precise sum today.

● Making a difference

A gift in your Will, regardless of size, makes a huge difference.

Some gifts are transformational such as the gift in the Will of a local resident that enabled us to purchase the land the Hospice proudly stands on today.

Typically the great majority of gifts help with the day-to-day costs of running the Hospice.



£1,680 - the cost of running our community team for one day



£10,000 - the cost of a bed with a specialist mattress in our inpatient unit



£100,000 - the cost of providing physiotherapy and occupational therapy for all our patients for a year
