## *Terms and Conditions*

- I acknowledge that I am attending Summer Sounds & Classic Cars event at my own risk, and that The Hospice of St Francis, the venue or suppliers of the event cannot be held liable for any injury, accident, loss or damage caused or sustained before, during or after the event, as a result of my attendance. Unless caused by the negligence of The Hospice of St Francis or third party supplier.
- The Hospice of St Francis cannot be held liable for any changes made to the event, including having to cancel or amend the attractions on offer for safety reasons or through other circumstances beyond their control.
- I understand that by purchasing tickets in advance of the event I am entitled to discounted tickets as follows: £10 per adult and £6 per child under the age of 18 years (Super Early Bird), £12 per adult and £6 per child under the age of 18 years (Advance Tickets). Under 3's and carers are free. Carers will also need to show proof. If I need more tickets on the day, these will be charged at full rate of £15 per adult and £8 per child under 18 years of age. Under 3's and carers will still be free.
- (If applicable) I understand that by purchasing Summer Sounds & Classic Cars Exhibitor tickets in advance of the event I am entitled to discounted tickets as follows: £10 per Classic Car and £6 per Motorbike. Entries on the day will be charged at the full rate of £12 per Classic Car and £8 per Motorbike. ***Summer Sounds & Classic Cars Exhibitor tickets include driver plus one passenger – any additional passengers would need to purchase a ticket (priced at £5 per person).***
- I understand that car and motorbike exhibitors may leave the event from 4:00 pm and as a result, any guests arriving after this time, may not see as many exhibitors. Exhibitors are encouraged to stay for as long as possible, but this will be at their own discretion.
- Summer Sounds & Classic Cars opens at midday and finishes promptly at 8:00 pm. We kindly request attendees leave the event field as soon as possible.
- I understand that parking on site is limited and we recommend car sharing or using public transport where possible. Pre-paid parking is only available at the time of booking your tickets. We cannot guarantee parking will be available on the day without pre booking a permit.
- I understand that cars must not be left in the event field overnight and that access gates will be locked at 9:00 pm on the evening of the event. If you need to gain access

after this time, please call 01442 869555 from 9:00 am on Monday 15<sup>th</sup> July and a member of our team can assist you.

- I understand that my ticket may not be fraudulently duplicated in any way to obtain entry. Tickets are unique to each booking and an email confirmation must be shown on entry.

***Please note: if you are purchasing tickets for a group who are not able to arrive together, then the email confirmation may be duplicated for the purpose of gaining entry. It is your responsibility to ensure that the correct number of people only are able to use your email ticket confirmation.***

- I understand that all pre purchased tickets are non-refundable, non-exchangeable and non-transferable. Should I or any member of my party not be able attend the event.
- I understand that should the event need to be cancelled due to reasons beyond our control we will make any reasonable effort to find an alternative date and your entry will be transferred over, but this is not guaranteed.
- I give my permission for my image to be captured (camera and film) by The Hospice of St Francis and outside sources. I understand that these images may be used indefinitely to promote the work of The Hospice of St Francis and its fundraising activities.
- I understand that my ticket covers my entry only to Summer Sounds & Classic Cars and other activities and refreshments may require additional spending of my own.
- The Hospice of St Francis reserves the right to change or amend the terms and conditions for entry to Summer Sounds & Classic Cars at any time.
- The Hospice of St Francis reserves the right to alter the line-up to any advertised events without any prior notice. An alteration to the event line-up does not constitute a cancellation and would not entitle you to a refund under these circumstances.
- All under 18s must be accompanied by an adult.
- We operate a Challenge 25 policy.
- Well behaved dogs on leads would be welcome, however please bear in mind the nature of the event. There will be crowds, cars and loud music. Please pick up after your dog and use the bins provided.
